About Us

Founded in 1810, Johnson & Perrott Motor Group is one of Ireland's oldest leading motor retailers with interests in commercial vehicle hire, motor dealerships and fleet management.

The company's dealership division represents 10 leading motor franchises for sales and service - CUPRA, Honda, Jaguar, KIA, Land Rover, MG, Opel, Peugeot, SEAT and Volvo new car franchises, together with Opel & Peugeot commercial franchises. Additionally, we operate an extensive CSS approved Bodyshop and are an authorised aftercare centre for Mercedes LCV's.

Operating from South City Business Park in Tallaght, Johnson & Perrott Fleet manages a fleet of over 1,600 cars and commercial vehicles for both domestic and international customers, ranging from blue chip multinationals leasing 1-100+ vehicles to home grown SME's with less than five.

Founded in 1980 and acquired by Johnson & Perrott in 2018, National Truck Rental is a market leader in the provision on short- and long-term contracts of over 1,000 commercial vehicles up to 30 tons and with a strong focus on refrigeration.

1810

Nelson Place Carriage Works founded by Joseph Smith in Nelson Place (now known as Emmet Place) Cork

1818

Company acquired by Robert William Edden.

1830

Factory rebuilt & modernised.

1861

Business acquired by James Johnson, (originally apprentice to Mr. Edden.)

1903

First secondhand car sold by Robert Perrott – Mr. Johnson's grandson.

1904

Partnership of Johnson & Perrott created.

1907

Johnson & Perrott Ltd incorporated – company no 3166 – William Perrott takes over management of company.

1918

Company sells
Rushbrooke Dock Yard
(more recently Verolme
Cork dockyard).

1922

Premises taken over by Free State Army during Irish Civil War. Returned after 2 months.

1933

Company appointed Bedford dealers.

1966

Johnson & Perrott Renta-Car established.

1968

New dealership constructed in Douglas for Vauxhall and Bedford.

1978

1982

Johnson & Perrott Fleet established.

1991

Avis Rent a Car acquired for Rep of Ireland.

2000

David Whitaker retires from the business and is replaced by son, Mark.

2003

Rebuild of Douglas Road premises completed.

2004

New premises in South City Business Park acquired.

2006

New dealership in Mahonpoint opened for three car franchises.

Premises in Emmet Place forms part of new retail district – Opera Lane.

2009

Opera Lane opens with full occupancy.


